

Cheniere Energy Partners Declares Quarterly Distributions

HOUSTON, April 20 /PRNewswire-FirstCall/ -- Cheniere Energy Partners, L.P. (NYSE Amex: CQP) today declared (i) a cash distribution per common unit of \$0.425 (\$1.70 annualized) to unit holders of record as of May 3, 2010, (ii) a cash distribution per subordinated unit of \$0.425 (\$1.70 annualized) to a wholly-owned subsidiary of Cheniere Energy, Inc. and (iii) a cash distribution of \$1.4 million to its general partner. All of these distributions are payable on May 14, 2010.

Cheniere Energy Partners, L.P. owns 100 percent of the Sabine Pass LNG receiving terminal located in western Cameron Parish, Louisiana on the Sabine Pass Channel. The terminal has send-out capacity of 4.0 Bcf/d and storage capacity of 16.9 Bcf.
