Twenty-five percent of this grant vested on 12/7/2023, the first anniversary of the grant date. Each phantom unit is the economic equivalent of one common unit of the Issuer.
- On 12/7/2023, the Reporting Person was granted 3,000 phantom units payable one-half in common units and one-half in cash. Each phantom unit is the economic equivalent of one common unit of the Issuer.
- The phantom units vest twenty-five percent on each of the first, second, third and fourth anniversaries of the grant date.
